Vaccine storage and ordering

Ensuring vaccines remain potent and effective is an essential element of immunisation practice. The cold chain begins at the point of manufacture and ends when the patient receives the vaccine. Public Health England (PHE) set out the processes and standards that should be adhered to in the *Protocol for the Ordering, Storing and Handling Vaccines*: <u>https://www.gov.uk/government/publications/protocol-for-ordering-storing-and-handling-vaccines</u>

Off label vaccine use

On 9th December 2014, PHE published two new resources focusing on the use of vaccines when they are "off label". The resources below may be useful in supporting conversations between immunisers and parents.

Off label use of vaccines may occur when: the cold chain has been broken or when national guidance on the use of the vaccine is not aligned with the *Summary of Product Characteristics*, such as a different schedule or used outside of the licensed age range. Immunisers should be able to identify when they are using a vaccine off label and inform patients/parents of this.

Primary immunisation - when to start and intervals between doses

What age can the first primary immunisations be given from?

Answer: Six weeks of age if indicated by individual circumstances, such as overseas travel to an endemic country.

Can the interval between doses of the primary course be reduced?

Answer: A four week interval is recommended between each of the three doses of DTaP containing vaccine in the primary schedule although if one of these doses is given up to a week early, either inadvertently or deliberately e.g. for travel reasons, then this can be counted as a valid dose and does not need to be repeated. However, no more than one dose should be given early in the three dose schedule.

Introduction to immunisation training 2015

The VACCSline team will continue to lead the design and delivery of basic immunisation training during 2015. The learning and development teams from Berkshire Healthcare Foundation Trust, Buckinghamshire NHS and Oxford Health have kindly agreed to continue to host and administer these events. Training dates and contact details are recorded below.

Health Education Thames Valley have provided funding which means that practice nurses who require basic immunisation training can access this without charge.

From 2015 this course will be delivered over two consecutive days (in line with the National Minimum Standards for Immunisation Training). A new programme has been designed based on feedback received from previous delegates and to reflect the complexities of immunisation practice. All delegates should have an identified mentor to support them with the work-based learning required to become a competent immuniser.
